



## Modern Slavery and Human Trafficking Supply Chain Transparency Statement

### Introduction

The California Transparency in Supply Chains Act of 2010 and the United Kingdom Modern Slavery Act of 2015 require certain businesses to provide a disclosure statement on their website concerning their efforts to address the issues of slavery and human trafficking in their direct product supply chains. The disclosures are intended to provide consumers information that enables them to make informed choices about companies they support.

### Our Supply Chain



InnerWorkings mandates supplier and factory social responsibility audits as part of our risk based audit program. We also monitor our supplier network through continuous screening against a database of heightened risk organizations.

InnerWorkings management is not aware of any slavery or human trafficking violations by any member of our supply chain and proper accountability standards would be put into place should they become necessary.
